2. HAZARDS IDENTIFICATION

Acute health effects

Skin contact Unlikely to cause skin irritation.

Eye contact May cause transient slight irritation.

Inhalation Minimal respiratory tract irritation may occur with exposure to large amounts of toner dust.

Carcinogenicity Carbon black is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). Carbon black in this preparation, due to its bound form, does not present this carcinogenic risk.

Physical hazards Not classified as a physical hazard.

Health hazards Not classified as a health hazard.

Environmental hazards Not classified as an environmental hazard.

In their evaluations of carbon black, both organizations indicate that exposure to carbon black, per se, does not occur when it remains bound within a product matrix, specifically, rubber, ink, or paint. Carbon black is present only in a bound form in this preparation. None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.
