2. HAZARDS IDENTIFICATION

Acute health effects

Skin contact Unlikely to cause skin irritation.

Eye contact May cause transient slight irritation.

Inhalation Minimal respiratory tract irritation may occur with exposure to large amounts of toner dust. Use of this product as intended does not result in inhalation of excessive amounts of dust.
