- HP Care Pack Service must have been registered with HP within 30 days of the original purchase date
- The hardware in question must not have had a service event for the life of the HP Care Pack. For this offer a service event will have occurred if HP either sends parts, a replacement or a person onsite to the customer or if the unit is transported to an HP repair depot during the life of the HP Care Pack Service. A phone call or phone support will not negate eligibility for the rebate.
